COURT ORDER

**VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES EFFECTIVE
January 1, 2010**

Pursuant to the Missouri Statute 479.050, Rule 37.49 of the Supreme Court Rules of the State of Missouri and the ordinances of this City, the undersigned Municipal Judge of the City of Clever hereby orders that the following designated offenses shall be payable to the City of Clever Violations Bureau. In such cases, no appearance is necessary.

Any violation resulting in personal injury or property damage may not be paid through the Violations Bureau.

Court costs shall be in addition to the fine.

SPEEDING

1-4 mph over the posted limit.....	\$25.00 fine plus costs
5-9 mph over the posted limit.....	\$50.00 fine plus costs
10-14 mph over the posted limit	\$75.00 fine plus costs
15-19 mph over the speed limit	\$125.00 fine plus costs
20-24 mph over the posted limit.....	\$175.00 fine plus costs
25-29 mph over the posted limit.....	\$250.00 fine plus costs
30 or more over the posted limit.....	must appear in court

Any second violation of a speeding offense will result in the set fine being doubled, plus court costs.

Any third offense within a two-year period of a moving violation, and any violation resulting in personal injury or property damage may not be paid through the Traffic Violations Bureau.


BOND

In the event the arresting officer feels that the person being arrested represents a risk to appear at court, bond for any of the above scheduled offenses may be set in a cash amount three times the scheduled fine or with a surety bond in the amount of \$1000.00. For any offense of driving while suspended or revoked the bond shall be \$500.00 cash or \$1000.00 surety. For any offense of driving while intoxicated or operating a motor vehicle with a

BAC over 0.08% the bond shall be \$750.00 cash or \$1000.00 surety. If the person being arrested for either of these offenses lives further than one contiguous county away from the Court, and since they either have no license or same is subject to revocation or suspension by the State of Missouri, and since this City has no means to compel their appearance by suspended their license for non-appearance then it shall be presumed there is probable cause to believe the person being charged will not voluntarily appear for Court and a warrant will be issued and bond posted. For an offense of assault the bond shall be \$500.00 case or \$1000.00 surety. For any offense of assault on a law enforcement officer or firefighter, \$1000.00 cash or surety. For any ordinance violation not listed or found herein, the bond shall be either \$250.00 cash or \$1000.00 surety.
